Dear doctor,

We have verified payment from your patient and accompanying caregiver (if any) for COVID-19 swab test and stay at SHN Designated Facility (if applicable). Kindly find the waiver letter attached.

As the doctor in charge, please note and comply with the following instructions:

Administrative details:

1. Inform patient and accompanying caregiver to carefully check their personal particulars on the Waiver Letter to ensure they correspond to the passport/travel document

2. Patient and any accompany visitor need to submit e-health declaration to ICA within 3 days prior to the date of their arrival in Singapore
3. The doctor in charge should book the receiving hospital's ambulance to fetch **both patient and caregiver** from the airport/ place of disembarkation to the receiving hospital for arrival swabs
4. Inform the patient that if he/she was not required to pay for stay at SHN Designated Facility, he/she should self-source accommodation for serving of SHN

#### Reporting of arrival information and medical appointments

1. **The doctor in charge** should consolidate and submit data for reporting to <https://go.gov.sg/pshnmedappt>. **Patient/ caregiver SHOULD NOT be submitting the above.**

#### Pre-departure testing

1. The doctor in charge should inform the patient (and accompanying caregiver, if any) to perform the necessary pre-departure testing as per MOH Circular 201A/2020.
2. The doctor in charge should interpret and certify the pre-departure test results (see attached) and send the completed form to the patient **AND MOH Hospital Services@moh.gov.sg**. The patient should print out the form on white paper and submit it along with waiver letter for inspection at Singapore checkpoint. MOH endorsement is not required.
3. **If ANY of the pre-departure tests are POSITIVE, the doctor in charge should inform the patient NOT to travel** and inform [MOH Hospital Services@moh.gov.sg](mailto:MOH_Hospital_Services@moh.gov.sg).

#### Arrival testing

1. Both patient and caregiver must be admitted and isolated at the receiving hospital on arrival in Singapore and be tested for COVID-19. If required test(s) are negative, the patient and caregiver can be discharged to the Stay-Home-Notice (SHN) location to complete their SHN. During the time in the hospital, patient can begin to receive the required specialist medical care that the patient had come for, if assessed to be appropriate by the attending specialist.

#### FAQs for foreign patients seeking specialist medical care in Singapore

1. Please find the updated FAQs attached for your information. This document is confidential and should not be disseminated to the patient and accompanying caregiver. The doctor in charge should convey the relevant instructions and is responsible in ensuring that the patient and caregiver abide by the prevailing guidelines.

#### Revised Circular on Foreign Medical Seekers

1. Please note the latest revised MOH Circular 201A/2020 (attached) for foreign medical seekers. Of note we will like to draw your attention to the revised criteria and processes highlighted in the circular.

Dear doctor,

We have reviewed and assessed your application which you had submitted on behalf of your patient **Hillier Christian Ian** for waiver of restriction on short-term visitors for entry into Singapore on medical grounds. We wish to inform you that your application is **approved in-principle**. **However, the patient should not make travel arrangements or undergo per-departure testing until we have issued you the MOH waiver letter.**

Please note that the patient and accompanying caregiver (if any) are required to pay for COVID-19 swab test to be done before end of Stay-Home-Notice (SHN) period and for stay at SHN Designated Facility (if applicable).

The estimated charges are as follows:

- COVID-19 swab test: up to \$200 per pax
- SHN Designated Facility – single room: \$2,000
- SHN Designated Facility – shared room: \$1,300 per pax

Please check the ICA website for the latest SHN regulations.

We will send a payment link to your patient and accompanying caregiver (if any). Once payment is verified, waiver letter and further instructions will be sent to you.
